NOTICE TO TAXPAYER

Notice is hereby given in accord with 32 V.S.A. §4111 that the undersigned Listers within and for the Town of Highgate have this day completed the abstract of individual lists (abstract) of property owners as of the 1st day of April, 2020. The Listers have lodged the abstract in the office to Wendy Dusablon, Town Clerk for the inspection of taxpayers.

On the **11th day of June, 2020 during the hours of 9:00-2:00** the undersigned Listers will be holding appeals of taxpayers aggrieved by actions of the Listers. Due to the health threat caused by the Coronavirus (COVID-19) and recommendations based on public health, we will not be holding face-to-face grievance hearings this year. If you wish to grieve, you **MUST** submit a grievance in writing with all supporting documents you wish to provide (photos, bank appraisals, etc) by **June 11th no later than 2:00 (postmarks not accepted)** as indicated in this notice. You are entitled to state the grievance in a hearing. If you wish to be heard in a live format in addition to submitting your grievance in writing, an appointment time will need to be scheduled and we will hold your grievance via ZOOM or Conference Call.




If we are unable to connect on grievance day via Zoom or Conference Call then the Listers will decide your grievance based upon the materials provided with your written grievance.
